In this document, you will also find a definitions page that details each cost terminology. While you are free to ask financial related questions/concerns at any point during Primary Fall Recruitment, Panhellenic Chapters will discuss financial obligations during Set II. Some chapters have predetermined costs for both the Fall and Spring, which will be reflected, while others are only able to give Fall financial responsibilities at this time.

Financial Transparency is an important part of striving for a more inclusive and diverse community, as well as being a crucial skill for graduate life. Finances can be overwhelming and stressful, especially during the Recruitment period. Please know that we, as the Panhellenic Executive Board, are here to support you throughout your Greek journey. I hope that you find the below information helpful in understanding each chapter more thoroughly. If you ever have any questions, please don't hesitate to reach out to your Recruitment Counselor, the Panhellenic Executive Board, or myself. Financial Transparency Definitions

Term	Definition
Inter/national Fee:	Fee paid to inter/national organization headquarters per member to support overall sorority operations.
Badge Fee:	If not included in the chapter's inter/national fee or the initiation fee, the member purchases the badge at their own discretion. Cost will vary.
Sisterhood Events:	These are events that are organized and managed by the chapter in an effort to build and support bonds between chapter members. Some examples of sisterhood events may include movie nights, painting nights, bowling, etc. Some chapters may induce extra billing for external events.
Philanthropy Events:	Each chapter has a philanthropic cause that they support, and some may have additional local causes that they support as well. This fee is associated with event set-up and apparel costs in relation to philanthropy fundraising efforts.
Meal Plan:	Food (meals and snacks) provided by the chapter to its members. Meal plans vary from chapter to chapter and some may offer reduced meal plan options.
Parlor/Facility Usage:	The entire chapter membership has access to the chapter facility and thus, the property is subject to wear and tear. This fee is used primarily for care and maintenance of the property and furnishings in the common areas of the chapter facility.
House Corporation:	These funds are utilized to support chapter property and physical plant.
Liability/Risk Management Insurance:	This fee covers insurance-related costs for the safety of members, their guests and sorority property. Funds may also be used for specific programming related to risk management concerns on campus or within the chapter.
Panhellenic Dues:	These funds are used to support Panhellenic operations. Examples of items that may be included in the Panhellenic operations budget are attending leadership conferences, office supplies, marketing, community-wide programming, and electronic media.
Rent:	Fees associated with the costs of living in a chapter facility. This is only for live-in members.
Other:	Some chapters may have additional fee categories, which will be specified and broken down in the "other" slot.

- It is important to note that while the Panhellenic Executive Board works diligently to provide a financial breakdown for each chapter, there are some variations between each organization and costs that we cannot account for. These costs include optional purchases that each member can make upon joining a chapter, which may include badge upgrades, apparel, or potential trips/activities.
- While the Financial Transparency Program is updated annually to represent each chapters' finances accurately, this is not a guaranteed breakdown and may be subject to change throughout the year. All questions and concerns pertaining to dues should be directed towards the chapters, as the Panellenic Executive Board has no input on chapter finances.
- Some boxes may list "N/A" rather than a specific price. This means there is no cost associated with that category.
- Some boxes may list "X" rather than a specific price. This indicates its cost is included in the overall dues but combined in another section, which will be disclosed under the title of the Panhellenic Chapter.
- Potential New Members are encouraged to speak openly about finances during recruitment and to ask their Recruitment Counselor if they have any questions. During Set 2 of Primary Fall Recruitment, chapters are required to discuss financial obligations, however Potential New Members can inquire about finances at any point during recruitment. If a chapter does not set aside time to discuss finances during recruitment, please inform your Recruitment Counselor immediately.
