Alpha Epsilon Pi 5-Year Conduct History

This report shows a comprehensive judicial history for Alpha Epsilon Pi the 5 years leading up to their loss of university recognition and includes any reports the university has received about the organization since. Below you will find some descriptions and definitions of the different sections of the report.

- Investigating Entity: The entity that oversaw the investigation. These entities can work in partnership or independently, depending on the details of the allegation.
 - o Dean of Students University of Arizona Student Assistance and Accountability
 - o Greek Standards Board Community Peer Judicial Board
 - o Headquarters organization headquarters/[inter]national offices
- Alleged Policy Violation: these policies can be found on the overseeing department's website. Please note some policies may have changed since the allegation. All university policies are available for public viewing, headquarters policies may be known to members only.
- Outcome: At the conclusion of an investigation, an outcome will be given. Throughout the investigation, it can be determined that an organization is not responsible but individual members are.
 - Responsible: More like than not the chapter/chapter members committed the allegation.
 - o Not Responsible: Evidence shows organization did not commit the allegation -OR- insufficient evidence to determine responsibility.
- Nature of Complaint: a copy or summary of the report that resulted in an investigation.
- · Sanctions: actions that must be completed for the chapter's good-standing to be re-instated

Once an organization has lost university recognition, the university has no jurisdiction to investigate reports. If the university receives reports of known or suspected policy violations, the is sent to local law enforcement (if applicable) and the national organization.

Alpha Epsilon Pi must successfully register a dry event by Friday, February 23rd. This event can be a philanthropic event, brotherhood event, community outreach etc. Alpha Epsilon Pi must restructure the chapter's Risk Management Policies to include the implementation of upper classmen partaking in sober security, and a policy for room checks and identifying members of age and those who are minors. Alpha Epsilon Pi's executive board must collaboratively meet and create a presentation on how they plan to hold members accountable at events. This presentation must be presented to the chapter by Monday, February 5th.

A meeting, with a chapter advisor physically or electronically present, must be held to inform the chapter facility residences of this policy change. Signatures from all the chapter facility residents must be collected to acknowledge they understand and will abide by the new policy.

Code of Conduct/EDUCATIONAL WORKSHOP: The Alpha Epsilon Pi chapter will create and distribute a paper survey (to be completed anonymously) to their current membership. The survey will be constructed with the assistance of the Assistant Dean of Students to assess the attitudes and beliefs of the current members in relation to new members. The survey results will be utilized to create an educational presentation for the Chapter. This educational presentation may be a panel of internal and external speakers on relevant topics such as alcohol consumption. Code of Conduct/FOLLOW UP MEETING: President of Alpha Epsilon Pi or his designee will meet with the Assistant Dean of Students every two weeks during the probation period. Code of Conduct/OTHER: The Executive Board of Alpha Epsilon Pi will pass a resolution to specifically prohibit behaviors such as line-ups.
