

## Pi Kappa Alpha 5-Year History

This report shows a comprehensive judicial history for Pi Kappa Alpha the 5 years leading up to their loss of university recognition and includes any reports the university has received about the organization since. Below you will find some descriptions and definitions of the different sections of the report.

- **Investigating Entity:** The entity that oversaw the investigation. These entities can work in partnership or independently, depending on the details of the allegation.
  - Dean of Students (DOS)– University of Arizona Student Assistance and Accountability
  - Greek Standards Board (GSB)– Community Peer Judicial Board
  - Headquarters (HQ) – organization headquarters/[inter]national offices
- **Alleged Policy Violation:** these policies can be found on the overseeing department’s website. Please note some policies may have changed since the allegation. All university policies are available for public viewing, headquarters policies may be known to members/HQ staff only.
- **Outcome:** At the conclusion of an investigation, an outcome will be given. Throughout the investigation, it can be determined that an organization is not responsible but individual members are.
  - Responsible: More like than not the chapter/chapter members committed the allegation.
  - Not Responsible: Evidence shows organization did not commit the allegation -OR- insufficient evidence to determine responsibility.
- **Nature of Complaint:** a copy or summary of the report that resulted in an investigation.
- **Sanctions:** actions that must be completed for the chapter’s good-standing to be re-instated

Once an organization has lost university recognition, the university has no jurisdiction to investigate reports. If the university receives reports of known or suspected policy violations, it is sent to local law enforcement (if applicable) and the national organization.

He added another part of the pledge process was, they were required to consume as much alcohol as they could. He bragged about consuming more alcohol than the other pledges and admitted to being very drunk.</li> <li>• The Tucson Fire Department responded and evaluate both (REDACTED). TFD decided to transport (REDACTED) to Banner.</li> <li>• (REDACTED) was arrested for Criminal Nuisance, False Reporting to Law Enforcement, MIP, Possession of a Fake ID and was transported to the Pima County Jail.</li> </ul>	<p>This letter confirms Pi Kappa Alpha's reinstatement, with the University removing the Interim Loss of Recognition status which was placed on PIKE in November 2020, therefore allowing PIKE to resume its previously authorized activities.</p> <p>As part of the reinstatement, PIKE local chapter in cooperation with National Headquarters, and Fraternity and Sorority programs, will undergo a membership review and engage in a collaborative new member process. This review is aimed to ensure all parties are working in a collaborative capacity for the foreseeable future, ensuring PIKE's continued success and adherence to the University's Code of Conduct.</p>

This event will NOT be held but should be used to discuss strategies to implement at future events that abide by all PAB Bylaws and the Student Code of Conduct.

This was discovered when UAPD asked the student at the door how many people have come through the event. The student had a clicker and it indicated over 2,000. UAPD also noted there was no mechanism in place to check people in and that guests flowed freely in and out of the event. The event appeared to be open to anyone.	1. Organize a meeting with each chapter's Fraternity and Sorority Programs liaison. Each chapter may do this individually. Following this meeting create an outline detailing guest list policies and procedures as well as FSP guidelines. 2. Create or update a chapter social event guest policy. This policy should reflect that of the Fraternity and Sorority Programs Social Events Policies.

It is alleged PIKE provided hard alcohol to a student who is under the age of 21. A student was found unconscious outside a resident hall around 12:30am November 2, 2018. The student had regained consciousness but then passed out again. UAPD and EMS was contacted and the decision to transport the student to Banner UMC was made. The student was not conscious at the time of transport. Friends of the student were able to share with UAPD that they had come from a fraternity party at PIKE. The friends were not sure how much alcohol the student had consumed but that this was her first time drinking and they only saw her consuming vodka. The student is under the age of 21. At approximately 0040 hours on 08-21-2018 I was dispatched to [REDACTED] residence hall reference a female subject vomiting in the public restroom located in room 251. Upon arriving I made contact with Sgt Kamper who advised TFD had already cleared and the subject was speaking with student EMS. After EMS had completed their assessment I made contact with UA student [REDACTED]. Student showed signs and symptoms of intoxication such as blood shot watery eyes, mumbled and slurred speech, and disarranged clothing. Student was advised of their Miranda Rights and agreed to answer questions by stating "yes" and "yes". Student stated she went out with a friend who is currently a sophomore. The two went to a party at PIKE fraternity (1525 E. Drachman) where she consumed alcohol. Student was not sure who served her alcohol or how much she drank, but said they knew she was underage. The female, later identified as [REDACTED], noticed me and walked in to the yard of the residence located on the south west corner of Cherry Ave. and Drachman St. and placed the bottle upright in the well of a palm tree and then walked away briskly. I parked my motorcycle and walked over to the tree well to investigate the bottle and found it to be a glass 750ml bottle of tequila that was approximately a quarter full of tequila. I returned to my motorcycle and searched for [REDACTED] who I found a short time later hiding behind a vehicle in the yard of a residence located at Vine St. and Mabel Ave. I called out to [REDACTED] to come out and identify herself and she complied. [REDACTED] said she was at the PIKE fraternity party and had only drank the "punch" they had provided and did not drink anything else. I smelled a slight odor of intoxicants on her breath and asked her to submit a breath sample into a PBT (preliminary breath test) which she did with positive results. [REDACTED] said an unknown "guy" gave her the bottle of tequila and she didn't know why she took it because she doesn't like tequila. [REDACTED] said she saw me and got scared so she decided to ditch the bottle and hide from the police.	<ol style="list-style-type: none"> <li>1. Pi Kappa Alpha must pay \$25 per member on their roster for violating the Student Code of Conduct. This does not include your fall 2017 new member class.</li> <li>2. Pi Kappa Alpha must write a formal guest policy that will be implemented by the chapter and shared to all members.</li> <li>3. Pi Kappa Alpha must refresh and restate their security plan and housing rules and policies for any gathering involving alcohol. The new statement is to be added to the chapter's housing corporation.</li> <li>4. Pi Kappa Alpha's President, Housing Manager and Sergeant-at-Arms will formally present the new guest policy, security plan, and housing rules and policies to their chapter.</li> </ol>
