Dear President

Pursuant to the Arizona Board of Regents Policy 5-401, et.seq. and in accordance with the Arizona Board of Regents Student Code of Conduct, this letter is to inform you that effective immediately, Theta Delta Chi is placed on *Activities Suspension*. *Activities Suspension* has been imposed pending the outcome of this investigation because it has been determined that your organization presents a substantial risk to members of the university community. *Activities Suspension* prohibits hosting, attending, participating, and sponsoring any organizational activities until the final disposition of this case. Club business meetings are the only allowed activities during this suspension.

Theta Delta Chi is prohibited from any contact with new members unless approved by the Dean of Students Office.

Reportedly on or about November 22, 2024, a new member was hospitalized due to a serious injury sustained while intoxicated after returning from Theta Delta Chi's Little/Big night. Following this incident, the university received a hazing report alleging forced alcohol consumption and multiple incidents of underage new members returning from chapter events intoxicated.

Such behavior is in violation of the Arizona Board of Regents Student Code of Conduct, pertinent parts of which are stated below:

Code of Conduct/2. Endangering / Threat / Cause Harm - Endangering, threatening, or causing physical harm to any member of the university community or to oneself, causing reasonable apprehension of such harm or engaging in conduct or communications that a reasonable person would interpret as a serious expression of intent to harm.

Code of Conduct/15. Alcohol - Violation of Board or university rules or applicable laws governing alcohol, including consumption, distribution, unauthorized sale, or possession of alcoholic beverages.

Code of Conduct/19. Hazing - Engaging in, supporting, promoting, or sponsoring hazing or violating Board or University rules governing hazing.

In order to discuss the allegations pending against the fraternity, a meeting should be scheduled by December 5, 2024. In this meeting, the Dean of Students Office will answer questions and explain the Student Code of Conduct Disciplinary process. It is expected that Theta Delta Chi fully cooperate with this investigation. Any acts impeding the disciplinary process are prohibited. Any contacts with the alleged victims for purpose of intimidation and retaliation are prohibited and will result in future disciplinary action. To schedule a meeting, please call 520-621-7057.

Please be advised it is against university policy to retaliate against anyone involved in the investigation. Should retaliation be alleged, it is a separate and distinct potential policy violation warranting another investigation. If this directive is violated, Theta Delta Chi may receive more restrictive sanctions, including but not limited to loss of recognition.
