Dear President [REDACTED]:

I have completed my investigation into the alleged violations of the Student Code of Conduct by Sigma Alpha Mu, reported to the Dean of Students (DOS) on March 10, 2026. The allegations pertain to behavior described below:

On March 10, 2026, Fraternity & Sorority Programs (FSP) notified the Dean of Student Office that Sigma Alpha Mu submitted paperwork to the FSP office that allegedly included forged signatures. Additionally, Sigma Alpha Mu is currently on University Probation for violations of the Student Code of Conduct occurring in October 2025 and has outstanding/overdue sanctions that were required to be completed by January 30, 2026.

On March 17, 2026, DOS notified Sigma Alpha Mu that they were being investigated for alleged violations of the Arizona Board of Regents Student Code of Conduct. The scope of the investigation was to determine whether there is sufficient evidence that Sigma Alpha Mu violated the Arizona Board of Regents (ABOR) Student Code of Conduct:

Code of Conduct/7. Failure to Comply - Failure to comply with the directions of university officials or agents, including law enforcement or security officers, acting in the good faith performance of their duties. This section is not intended to prohibit the lawful assertion of an individual's fifth amendment right against self-incrimination.

Code of Conduct/8. Forgery / Unauthorized Alteration - Forgery, falsification, fabrication, unauthorized alteration, or misuse of campus documents, records, or identification, including, but not limited to, electronic software and records.

On April 14, 2026, DOS notified Sigma Alpha Mu that they were being placed on **Activities Suspension** pending the final disposition of this investigation.

On April 16, 2026, Sigma Alpha Mu met with the Dean of Students Office to discuss the code of conduct process and the pending allegations. During the meeting, Sigma Alpha Mu acknowledged the following:

You, as President of Sigma Alpha Mu, accepted full responsibility for failing to complete the DOS sanctions related to the Fall 2025 incident by the assigned deadline of January 30, 2026. You stated that these sanctions were incomplete, in part, due to the transition of leadership following the former President's departure.

The Sigma Alpha Mu Social Chair acknowledged and took responsibility for your Chapter Advisor's signature being forged on paperwork for a Spring 2026 Sigma Alpha Mu social event. The Social Chair stated that he was in the process of training a new member/first-year student on how to complete the paperwork. The Social Chair stated that he believes the new member panicked, forgot to obtain the advisor's signature on the paperwork, and signed it himself. Further, the Social Chair stated that the new member forged all signatures on the paperwork (Advisor, President, and Social) and acknowledged that he should have provided more oversight and training to the new member before tasking him with completing the social paperwork independently. Going forward, you, as President, have determined that all paperwork will be reviewed and approved by the Executive Board before submission.

Based on the totality of information provided to DOS, I find it more likely than not that there was a violation of the Arizona Board of Regents Student Code of Conduct, items:

Code of Conduct/7. Failure to Comply - Failure to comply with the directions of university officials or agents, including law enforcement or security officers, acting in the good faith performance of their duties. This section is not intended to prohibit the lawful assertion of an individual's fifth amendment right against self-incrimination.

Code of Conduct/8. Forgery / Unauthorized Alteration - Forgery, falsification, fabrication, unauthorized alteration, or misuse of campus documents, records, or identification, including, but not limited to, electronic software and records.

The following sanctions are being imposed in response to the violations of the Student Code of Conduct:

1. MONETARY SANCTION - Organization

Amount: \$4400

Start Date: Thursday, April 16, 2026

Complete by: Thursday, April 30, 2026

All organizations found responsible for violating University policy are assessed a non-refundable monetary sanction of \$25 per member. The non-refundable monetary sanction is to be paid by check made payable to the University of Arizona and hand-delivered to the Dean of Students Office, Robert L. Nugent Building, Room 100.

176 (members) x \$25 (per member) = \$4400

2. ACTIVITIES SUSPENSION - Organization

Start Date: Thursday, April 16, 2026

The Dean of Students Office has elected to modify your Activities Suspension, and, effective immediately, Sigma Alpha Mu is placed on Activities Suspension with alcohol.

Activities Suspension with Alcohol prohibits hosting, attending, participating in, or sponsoring any organizational activities involving alcohol.

This sanction will remain in effect until Sigma Alpha Mu has completed an alcohol education workshop with 100% attendance and completed its Risk Management Policy Review.

3. OTHER - Organization

Start Date: Thursday, April 16, 2026

Complete by: Friday, September 04, 2026

Risk Management Policy Review:

The organization has agreed to a Risk Management Policy Review, which should include the following:

- Substance-free new member events**
- Prohibition of drinking games**
- Chapter Honor Board referral for alcohol violations**
- Alcohol Safety Training**
- Sober Event Monitors**
- An Outline of Potential consequences for violations**

Risk Management Policy review must be completed prior to the start of Fall 2026, IFC Recruitment.

4. ALCOHOL EDUCATION - Organization

Start Date: Thursday, April 16, 2026

Complete by: Friday, September 04, 2026

Your organization is required to host, in consultation with the Fraternity and Sorority Programs staff, a comprehensive Alcohol education program with 100% documented attendance by organization members.

The Alcohol Education Program must be completed prior to the start of Fall 2026, IFC Recruitment.

5. OTHER - Organization

Start Date: Thursday, April 16, 2026

Complete by: Thursday, April 16, 2026

Sigma Alpha Mu is required to hold monthly meetings with a representative from Sigma Alpha Mu Headquarters.

At a minimum, the meeting is to include the Chapter President and HQ representative. Additional chapter officers may be included at the discretion of the President and HQ representative.

The Chapter President will be required to send a copy of the monthly agenda/talking points to the Dean of Students Office (isabellam1@arizona.edu) each month.

6. UNIVERSITY PROBATION - Organization

Start Date: Thursday, April 16, 2026

Complete by: Monday, January 18, 2027

The organization is being placed on probation. Probation means that any violation of the prohibited conduct items in the Student Code of Conduct, including failure to comply with these sanctions, will lead to further disciplinary action, which could include loss of recognition.

Sigma Alpha Mu will remain on University Probation through January 2027. Probation is subject to extension if educational sanctions are not completed by this date.

It is the responsibility of Sigma Alpha Mu to provide written documentation immediately upon completion of each sanction.

If these items are not completed by the affirmed deadlines, or if further disciplinary issues arise, including non-completion of or non-compliance with the aforementioned sanctions and action plan items, Sigma Alpha Mu could face additional disciplinary sanctions, including, but not limited to, loss of recognition.

The Student Disciplinary Procedures do not provide for a formal appeal of this case. If you feel, however, that you have new information or you believe that you have been treated unfairly, submit a written statement to the Dean of Students Office, within ten business (10) days, April 30, 2026, of receiving this letter, requesting a review of your disciplinary file.
