This letter confirms the Greek Standards Board meeting on November 28th, 2018 regarding Zeta Beta Tau's alleged violation of the Events with Alcohol Policy. Based on the testimony presented during the hearing of your case, the Greek Standards Board, after a 5 to 2 vote, has determined that your chapter is responsible for the violation of the Events with Alcohol Policy Section 2. After a 7 to 0 vote, the Board has also found your chapter responsible for the violation of Events with Alcohol Policy Section 5.

Policy Violated:

**Events with Alcohol Policy
Section 2. Registration**

G. All events involving alcohol must be registered with the Fraternity and Sorority Programs Office.

Section 5 – Security

A. Security must be provided throughout the duration of events with alcohol, relative to the guidelines of Section 5, F and G.

This decision was based on careful consideration of all the information before the Greek Standards Board, which included admittance that cans of beer may have come from live-ins who violated the chapter house policy, the likelihood that alcohol could have been in the red solo cups at the event, and that members were avoiding talking with UAPD when they arrived. In addition, the admittance to not being able to book security for the night when alcohol was seen to be present lead to this decision by the Board. This decision was based on the preponderance of the evidence, meaning whether it was more likely than not that the alleged conduct or behavior occurred.

As a result of this decision, the Board has agreed that the following sanctions shall be imposed on your chapter.

1. Zeta Beta Tau must give a presentation about expectations at registered dry events and events with alcohol to both the incoming executive board and the entire chapter. This presentation should cover what dry events entail and what protocol will be used if police arrive at the event. A copy of this presentation as well as a picture of the chapter in attendance at the presentation will be due to gsb.chiefjustice@gmail.com by **Friday, January 18th at 5pm.**

2. Zeta Beta Tau must register a dry event for next semester on campus. Registration will be confirmed by Fraternity and Sorority Programs. This event must be registered by **Friday, January 18th at 5 pm.**

Zeta Beta Tau has the right to an appeal. A written request must be submitted to DOS-deanofstudents@email.arizona.edu by Monday, December 10th, 2018 at 5:00pm. Your written request must include rationale for the appeal. All appeals will be reviewed by the Dean of Students Office.
